New Program Expands Skills of Dental Assistants in South Dakota

In an effort to increase the utilization of the Expanded Function Dental Assistant (EFDA) in South Dakota, Lake Area Tech is offering an opportunity for dental assistants to further their education or to refresh their skills and knowledge in multiple expanded functions with minimal time away from home and work.

The new education program, being offered by the Dental Assisting Program at Lake Area Technical Institute, includes a curriculum for expanded functions that may be used by advanced dental assistants or dental assistants with a minimum of one-year work experience to provide a career ladder through advanced education, skills and responsibility. The program's curriculum will be organized in multiple modules. The courses may be taken in sections as continuing education for assistants wishing to further their education or to refresh their skill and knowledge in any one expanded function. When

completed in its entirety the course will lead to a verification of competency approved by the South Dakota State Board of Dentistry fulfilling the education requirement for an Advanced Dental Assistant.

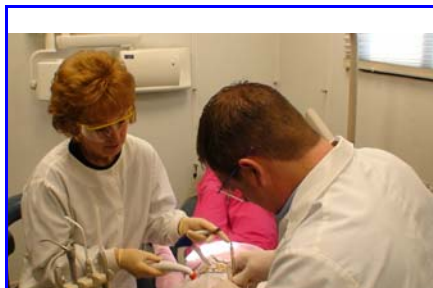

The following are ideas for helping you promote the benefits of good oral health to children, parents, teachers and caregivers:

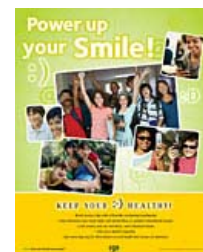

“Women, Witches & Wisdom: New Research on Women’s Oral Health”

Men may be from Mars but women have two x chromosomes. Gender based biology is identifying the role female hormones play on various aspects of oral health. This program examines oral health

throughout a women’s life. From puberty and adolescence through your adulthood, to middle and older adults, this seminar will discuss oral diseases and conditions affecting girls and women from the common (caries, periodontal diseases) to the uncommon (eating disorders, Sjogren’s syndrome, TMD, domestic violence). The program will discuss factors and how to identify them clinically, and strategies for prevention. Five hours university/clinical CE.



Kim Laudenslager, RDH, MPA
“OSHA/Infection Control Training”

This course will be a fast paced review of material OSHA requires for annual training. In addition, the most current information available on infection control procedures, infectious diseases and product reviews will also be presented.

Individuals who have not had previous training are also encouraged to attend with the understanding that additional reading (i.e.; homework) may be necessary following the course for them to fully comprehend the material. Four hours university/clinical CE.

“Introducing Tobacco Cessation Treatment in Dental Health Practices”

The objectives of this course include: the history of treating tobacco use and dependence in Wisconsin; outreach efforts to dental hygiene students at Wisconsin

technical schools; an abridged CME on treating tobacco use and dependence, which includes a section on FDA-approved medications; collaborative efforts with dental health insurers to treat tobacco use; staff roles in treating tobacco use; spit tobacco awareness and treatment; and, motivating patients who use tobacco to make a quit attempt. Two hours university/clinical CE.



Chester Douglass, DMD, PhD
KEYNOTE ADDRESS
“The Emerging Market for Dental Care in the U.S.”

The relative importance of dental care within health care expenditures in the US economy is highlighted in this keynote address. The reduction in the numbers of newly qualified dentists since 1985 is described as an issue which has resulted in economic growth within the dental services sector and problems in maintaining a sufficient dental workforce. A trend towards increasing the proportion of specialists is outlined. Mechanisms for payment of dental care and different types of dental insurance schemes are described. Declining access to dental care for lower income groups is identified as an issue associated with the under-supply of dental care providers and the relative reduction in the level of reimbursements for dentists working within programs set up for these groups. One hour university/clinical CE.

“Current Concepts in Geriatrics for the Dental Team”

The rapid growth of our older population is presenting dental professionals with many new challenges in clinical care.

Implant supported restorations have become increasingly commonplace and the potential for peri-implant inflammatory reactions and early and late loss of osseous support may adversely effect successful outcomes and compromise results. This presentation will focus on peri-implant soft and hard tissue complications. Discussion will include prevention of complications with early treatment planning, current maintenance protocols, and review of common complications. The lecture will also review treatment for ailing and failing implants. Three hours university/clinical CE.



Edward Mailloux, MD
“Oral Manifestations of Child Abuse & Neglect: Recognition and Reporting”

The objectives of this course include: Define the South Dakota law regarding child abuse and neglect and mandated reporting; Describe the guidelines for making the decision to report child abuse and neglect; Describe the process for making the report of child abuse or neglect; Describe what happens after a report is made; and, Dental implications of child abuse and neglect.

Implant Symposium



Thomas Salinas, DDS
“Replacement of Single & Multiple Missing Teeth With Osseointegrated Technology”

The ever changing face of technology has influenced today’s approach to treating patients faced with the loss of a single or multiple teeth. This presentation identifies the traditional standards at which dentists have practiced osseointegrated implant dentistry and compares emerging technologies which stand to improve its outcomes. Nouveau material selection, along with computerized milling, has entered a new era as these technologies have merged with opportunities for unique esthetic and functional application. This confluence has changed the approach to solving traditional problems associated with casting accuracy, biomechanical failure, and introduction of errors into fabrication phases. Biomechanical principles will also be discussed in design of these restorations with special emphasis on materials commonly used. One and a half hours university/clinical CE.



Robert Schneider, DDS
“Everything You Wanted To Know About Implant Overdentures”

Implant retained and implant supported overdentures will be discussed in detail both for the mandible and maxilla. In addition to clinical indications and treatment, laboratory considerations and techniques will be presented. Traditional techniques along with titanium laser welding will be show. One and a half hours university/clinical CE.

Dental Designs Lab
“Team Approach to Implant Dentistry: Coordinating the Implant Team”

Course highlights include: treatment planning; pre-surgical case development; surgical guides; single, multiple unit and full denture case design; screw retained vs. cement retained restoration; surgical office and dental lab protocols; and, latest computer technology in scanning implant design.
