KEYNOTE ADDRESS: DAN MEERS

Dan Meers goes to work each day like many other men, dressed in a suit. The only difference is that instead of wearing a tie with his suit, Dan wears a tail. You see, Dan is a professional mascot. Dan began his career in 1986 at the University of Missouri-Columbia, dressed as the Truman Tiger. He was selected the nation's #1 college mascot in 1989 and began receiving offers to use his talents at the professional level. He began his professional career as Fredbird, the mascot for the St. Louis Cardinals. Soon he would trade his bird suit to become a wolf. Today Dan is widely known as KC Wolf, the official mascot of the Kansas City Chiefs. He travels throughout the United States and the world entertaining thousands of people both in and out of costume. Dan is in high demand not

only as mascot, but also as a humorous and motivational speaker. His enthusiasm, optimism, and love for life are contagious and makes Dan an inspiration to all those he meets.

Dental hypersensitivity is a common dental condition that affects approximately 57% of the general population. Dental hypersensitivity can be caused by a variety of factors; however, one cause often overlooked or simply ignored is improper manual and ultrasonic instrumentation. I'm Not Quite Healthy, but Not Quite a Cavity: "Understanding the vast continuum that separates healthy enamel on one side, to a lesion in need of a drill and fill, on the other."

Advances in imaging, lasers, and artificial intelligence have made it much easier to identify incipient enamel lesions way before they become frank cavitation requiring invasive interventions, usually involving an injection, a drill, and a costly restoration. 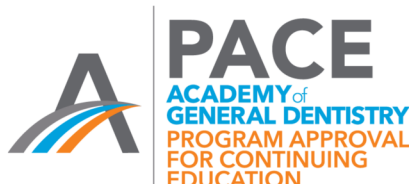

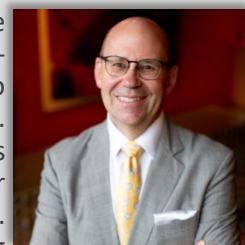

Drug-Related Problems in Dental Practice: "It's a Minefield Out There!"

Increasing numbers of dental patients are uncontrolled hypertensives or on multiple medications with complex oral health problems. Many new cardiovascular and central nervous system drugs can interact with dental drugs or affect bleeding or wound healing. Patient self-medication with cannabinoids or psilocybin has recently been recognized as potentially risky in dentistry. Consequently, more and more patients report chemical and drug allergies and intolerances. Dental professionals are frequently faced with medically complex and chemically challenged patients and need practical strategies for providing safe and appropriate care.
